The Boys JV HS Players League will be on Sundays beginning June 6<sup>th</sup> at 6:00 PM. The games will be played every Sunday evening from June 6, 2010 and continue thereafter on each successive Sunday with the exception of two games that must be moved to Saturdays to accommodate the Professional Soccer United Teams. The two Saturday games will be on July 31 and August 7<sup>th</sup>. Two approved Missouri Lacrosse officials will be officiating at each game.

All players will receive team jerseys schedules on the night of their first game on June 7th.

This is a regulation full contact program and requires each player to wear all MSLA required equipment, including helmet, shoulder pads, arm pads, gloves athletic supporter and mouth guard during every game.

**The schedule of games will be as follows:**

All games are on Sunday evenings on Field No. 2 with 3 games in succession starting at 6:00 PM; 7:10 PM and 8:30 PM lasting for one hour per game. Schedules will be available at the first game.

The league fee for the eight (8) week Summer Program is \$135.00. If you register by May 20<sup>th</sup> you will receive a \$10.00 discount. If you register after May 31, 2010 there will be a \$25.00 Late Fee charged with your registration fee.

Goalie's fee for the eight (8) week Summer Program is \$75.00. Receive a \$10.00 discount if you register by May 20, 2010.
